Standing allowed in bar in limited numbers to allow social distancing. 80 seated + 40 standing.</li> <li>• Queue system in operation to bar using floor arrows.</li> <li>• Maximum 5 people at bar at any time.</li> </ul> <p><b>Entrance into TH from stadium for Toilets</b></p> <ul style="list-style-type: none"> <li>• Hardboard/Perspex Screen to split main door into exit and entry point</li> </ul>	<p>Updated “Reds Covid Code’ to be displayed in hard copy all around the Stadium Premises</p> <p>Top up bottle to ensure they have fluid at all times</p> <p>Signage to indicate face masks recommended in TH Bar. Recommendations for face coverings in indoor spaces announced on tannoy 10/15 minutes before half time</p> <p>Path to bar identified and barrier to ensure compliance.
